

Website Terms & Conditions of Use

The following terms and conditions of use (the "Terms and Conditions") govern your use of this J. Giordano Securities Group, LLC Web site (the "Site"). The Site is made available by or on behalf of the J. Giordano Securities Group, LLC ("we", "us" or "J. Giordano"). We may change the Terms and Conditions from time to time, and at any time, with or without notice to you, by posting such changes on the Site. If you do not agree to these Terms and Conditions, you may not access or otherwise use the Site. By using the Site following any modifications to these Terms and Conditions, you agree to be bound by such modifications to the Terms and Conditions.

1. Services Available on the Site. We may make certain content and services available to you on or through the Site. 2. Proprietary Rights. a. Types of User Information.
